Yours for a happy Community SUNSHINE COMMITTEE CONSTITUTION AND BY-LAWS OF THE SUNSHINE COMMITTEE, SUN CITY ARIZONA. HISTORICAL BEGINNING: In the Spring of 1961, after \$40.00 was set as the amount for dues, per home, in the Civic Association Inc., the Sunshine Committee was formed with The Rev. Duane Thistlethwaite as Chairman, to help those who needed it in paying their dues. Most people did not want this kind of help, so we began to help them to get jobs, that they could pay their own dues.

Soon we began to see the need for other types of help. The old Committee was changed on October 5, 1961 by the Bresident of the Sun City Civic Association Inc., Mr. Roy Luts, and a new Committee with The Rev. E. Duane Thistlethwaite as Chairman, Mrs. Carl Kays, Mrs. Joseph Asteres, Mrs. George Heath and Mrs. Marren Rogers was formed. New Life and Sun City Units were divided into four Districts, and each of the women became Chairman of their District. As we grow, more Districts will be added to fill the meed. We now have nime Districts.

Association Inc. and the Sun City Civic Association had the same officers, the SUNSHINE COMMITTEE was transferred to the Sun City Civic Association so that it's work could cover the whole of a growing Sun City Arizona.

On December 27, 1962, The Sun City Civic Association approved the Constitution and By-Laws of the Sunshine Committee of Sun City, giving to them greater freedom in their work to help others in Sun City. In 1963, the name of the Sun City Civic Association was changed to Sun City Home Owners Association and it was incorporated. CONSTITUTION OF THE SUNSHINE COMMITTEE OF SUN CITY, ARIZONA. ARTICLE I The legal name of this organization shall be SUNSHINE COMMITTEE OF SUN CITY ARIZONA.

ARTICLE II It shall be a non-profit organization. ARTICLE III It's purpose shall be to aid the citizens of Sun City in any emergency

where they may be of help, with the emphasis on service to others regardless of crosd.

BY-LAWS OF THE SUNSHINE COMMITTEE OF SUN CITY, ARIZONA: (As revised October 14, 1963)

ARTICLE I MEMBERSHIP AND VOTING RIGHTS:

 The membership of the Sunshine Committee shall include all members of the Executive Committee as defined in Article II-A-2, Sub-District Chairmen, Car pool representatives, Neighborhood Chairmen and other appointed workers of the Sunshine Committee.

2. Each of such members shall be eligible to vote at the annual meeting and at other called general meetings.

ARTICLE II (A) EXECUTIVE COMMITTEE :

- 1. The executive Committee shall be the ruling body of the Sunshine Committee. It will be their responsibility to establish and see o carried out, the working rules, regulations and policies necessary to the performance of the activities required to fulfill the purpose of the Sunshine Committee as specified in Article II & III of the Constitution.
- 2. The Executive Committee shall be comprised of Director, Assistant Director(if any), District Chairmon and their Co-Chairmon, Secretary, Treasurer and Publicity Chairman.
- The meetings of the Executive Committee may be called by the Director or by three District Chairmen.
- (B) ORGANIZATION:
- 1: The Director shall be the Executive Officer of the Sunshine Committee. He shall be selected by the Sunshine Committee(Executive) before January let, following the Annual Meeting, and approved by the incoming President of the Sun City Home Owners Association. He will be responsible for carrying out the rules, regulations and policies of the SUNCHINE EXECUTIVE COMMITTEE.

2. An assistant Director may be appointed by the Director with the approval of the Executive Committee. His duties will be to assist the Director and to assume responsibilities of Director in his absence.

- 2. District Chairmen will report to the Director or his Assistant and will be responsible for the performance of such duties and activities in their respective Districts as are necessary to carry out the purposes of the Sunshine Committee.
- 3. District Chairmen will appoint their own Co-Chairmen to assist them with the work and assume their responsibilities in their absence. They may appoint such other assistants in the work, such as sub-District and Neighborhood Chairmenand a Car Pool Sommittee.
- (B) SECRETARY-TREASURER-PUBLICITY CHAIRMAN:
- 1. A Secretary shall be responsible for the minutes at meetings and carrying on correspondence for the Sunshine committee.

Such notice will be either by direct notice to members or by publication in a local newspaper at least 10 days prior to the date set for the Annual Meeting.

 The Annual Meeting shall be held for the purpose of electing Chairmen, receiving reports and for the conduct of any other business that may properly come before the Meeting.

3. Prior to the Annual Meeting, The Executive Committee shall appoint a Nominating Committee, which will submit at such meeting the names of nominees for each District Chairman to be elected. Additional nominations may be made from the floor of the Annual Meeting. The nominee receiving the majorityvotes for their respective District shall be declared elected to the office. This does not imply that changes need be made annually in the Organisation and it is hoped that all dedicated workers will continue in office.

1st AMENDMENT TO BYALAWS IN ORIGINAL CONSTITUTION AND BY-LAWS :

•*In event of the dissolution of this Organization, all assets remaining after payment of cutstanding liabilities shall be distributed to a State, Federal or Local Government to be used for public purpose."

• This was passed unanimously at a Meeting of the Sunshine Executive Committee on February 18, 1965. This was done so that wheever makes a gift(whether new or in a will) to the Sunshine Committee, will know in advance that it can be deducted from their taxes. We believe that we are doind a great work in Sun City, but that the demands will continue to increase , and the more money we have, the better we will be able to meet these demands.

The above CONSTITUTION AND BY-LAWS was adopted by the Sun City Sumshine Executive Committee, October 14, 1963, with additions and revisions of the Constitution and By-Laws as passed by the Sun City Civic Association, December 27, 1962 and with amendment as passed and included above.

BY-LAWS OF SUNSHINE SERVICE, INC.

SUN CITY, ARIZONA

ARTICLE I MEMBERSHIP AND VOTING RIGHTS:

1. The membership of Sunshine Service shall include all Directors, District Chairmen, Co-Chairmen, Sub-District Chairmen, Neighborhood Chairmen, Car-Pool Representatives and other appointed workers of the Sunshine Service, Inc.

2. Each of such members shall be eligible to vote at the Annual Meeting and other general meetings. Membership Cards will identify voting members.

ARTICLE II (A)

1. There shall be 17 Directors elected at the Annual Meeting. The Directors regular meeting shall be held the 3rd Thursday morning of each month. The elected Directors of Sunshine Service shall be the ruling body of this corporation. It will be their responsibility to establish and see carried out the working rules, regulations and policies necessary to the performance of the activities required to fulfill the purpose of this organization as specified in the Incorporation.

2. The Executive Committee shall be composed of President, Vice President, Secretary and two others elected by the Directors; preference should be given to those who are here most of the year.

3. The meetings of the Executive Committee may be called by the President or by three Directors.

(B) ORGANIZATION:

1. The Fresident shall be the Executive Officer of the Sunshine Service. He shall be elected by the Directors following the Annual Meeting. He will be responsible for carrying out the rules, regulations and policies of the Directors.

2. The Vice President shall be elected in like manner. His duties will be to assist the President and to assume responsibilities of the President in his absence.

3. A Secretary and a Treasurer shall be elected by the Directors.

(C) CHAIRMEN AND CO-CHAIRMEN:

1. District Chairmen will be appointed by the President, and approved by the Directors, and will hold office until their successors are installed in office.

2. District Chairmen will report to the President or his Assistant and will be responsible for the performance of such duties and activities in their respective District as are necessary to carry out the purpose of the Sunshine Service, Inc.

3. District Chairmen will appoint their own Co-Chairmen to assist them with the work and assume their responsibilities in their absence. They may appoint such other assistants in the work, such as Sub-District and Neighborhood Chairmen and a Car Pool Committee.

(D) SECRETARY -- TREASURER -- PUBLICITY CHAIRMAN AND OTHERS:



At the regular meeting of the Executive committee of the Sumshine Committee, October 15, 1964, with 15 present and the Director, E. Duane Thistlethwaite, the following motion was made seconded and passed unanamously,-

"Mrs. Hazel Meyer made a motion, that after Re. Thistlethwaite talks to this attorny (Allan K. Perry) and he feels # that there are no obstacles, legal or otherwise, that we go ahead and vote to incorporate. This motion was seconded by Mrs. Henrietta Howe and cerried unanamously."

At a Special meeting of the Executive committee authorized by the Meeting of October 15, 1964, The fallowing motion wade by Mrs. Ann Meath, "with intention of incorporation, "I move that we change the name of the Sunshine Committee to Sunshine Service, Inc.- this was seconded by Mrs. Julia Solem and carried."

We incorporated the SUNSHINE SERVICE, October 30, 1964 and all funds and ascedts were continued under the name of Sunshine Service that had been under Sunshine Committee and with almost the same officors. This was all done so that we could receive a deed from Dell Webb organization for land on which to build a Storage building. The Home Owners Association approved this plan and gave us § 1,000.00 for our new building.





WHAT IS IT?

It is an organization dedicated to helping our neighbors in time of illness, bereavement or heartache of many kinds.

WHO PROVIDES THIS SERVICE? The Sunshine Board has a chairman and 24 members which meets each month. In addition it has nearly 400 district chairmen, sub-district each month. In addition it has nearly 400 district chairmen, sub-district chairmen, neighborhood chairmen, car pool members et al. All service by these people is voluntary. There are no paid workers, except the office secretary.

WHAT DOES IT DO?

During the last six years it has built up a large collection of sickroom equipment, including hospital beds, trapeze, walkers, wheel chairs, commode chairs, hydraulic lifts, traction units, and many smaller pieces of equipment. These are loaned, without charge, to any Sun Citian who requests them. We also have roll-a-way beds for your use. The neigh-borhood chairman visits those in their neighborhood who are alone or ill. They offer their service, if desired, in time of bereavement.

The Service has a car pool which takes Sun Citians to clinics and hospitals, in an emergency. The Service provides all residents with an emergency window card. (This card contains vital information for use in an emergency.)

The Service also, at times, can help you get household or nursing help, in case of accident or illness. (The remuneration paid such help is a matter between those who need help and those who want work.)

HOW IS IT FINANCED?

By contributions and memorial gifts from individuals, organizations and clubs. Those who use the equipment often make donations. We have no other means of support.

HOW IT ALL CAME TO PASS

A Short History

In 1961 the then Sunshine Committee was appointed by the Sun City Civic Assn. Inc. Its initial purpose was to help Sun Citians who were unable to pay their dues for the upkeep of the recreational facilities, meeting hall, etc., which had been turned over to the residents by the Del Webb organization. Five of the directors contributed \$40 each to a fund for this purpose. Also appointed at this time was a Sick and Visiting Committee, with Rev. E. Duane Thistlethwaite to head both committees. With the \$200 the Committee paid the first quarter dues for four homes. The people for whom this was done said "We would rather pay our own dues if we had work." So the Committee found work for three and paid only for one during the second quarter. This left a balance of \$150 in the treasury. It was agreed that all checks had to be signed by two members of the Committee who knew where the money was going, but it was to be made known who received the help.

Later all activities were consolidated under one committee. Rev. Thistlethwaite was appointed chairman (he still heads the organization.) Four women were appointed to head four districts in the community. They in turn appointed their co-chairmen, sub-district and neighborhood chairmen. This procedure continued until there were hundreds of these chairmen in Sun City.

When the Committee found that a Sun Citian was paying \$35 for a hospital bed for one month and the opportunity arose to buy hospital beds and mattresses from Memorial Hospital at \$25 each, the decision was made to spend one half of the \$150 in the treasury for three beds. A Sun Citian offered to buy the fourth bed. So began the supply of Sunshine Service sickroom equipment now worth thousands of dollars. (The second-hand equipment has long since been replaced by new equipment.)

The first bed and mattress and wheelchair were loaned in April, 1962. The number of pieces of equipment continued to grow and when not in use were stored in Rev. Thistlethwaite's apartment. His wife, Fern, was the telephone and office girl.

Finally the equipment in Rev. Thistlethwaite's apartment threatened to displace the residents, so the Board proposed a separate building to house the equipment.

The Sunshine Committee had to incorporate in order to accept a deed for a lot on which to build the Sunshine Building. The Del Webb Corporation provided the lot and built the building at cost. The estimate for the building was \$14,000. A simulated thermometer was placed in the Grand Avenue shopping center and letters were sent to Sun City clubs and organizations asking for contributions. Soon checks began to arrive from individuals as well as from the clubs and organizations to which the plea had been sent. When the thermometer registered \$12,000, work began. The building was constructed for less than \$12,000 and all improvements and landscaping were given by the Webb Company. The key to the 30 x 50 foot building was received on July 1, 1965.

Sun City and the Sunshine Service continued their record growth. By the end of 1968 more storage room was needed. Therefore the Sunshine Service decided to add on to the building, making it 30 by 110 feet and also installing much needed shelving. Sun Citians gave \$9,000 to pay for the addition which the Del Webb Company again constructed at cost.

It has never been the policy of Sunshine Service to ask individuals for money. Letters were sent only to clubs and organizations in Sun City. However, the organization receives many gifts from individuals. Though not required, it is the usual custom for those who borrow sickroom equipment to make a contribution to Sunshine Service when returning the equipment.

AN APPRECIATION

Who has been responsible for this unique service of concern for and helpfulness to their neighbors? The immediate answer is the people of Sun City and the Del Webb Corporation. Where is there a service of this kind? There may be something similar elsewhere but it is doubtful that it is as far-reaching, as helpful, as quick in an emergency, as quiet and as kind. 

WHAT IS IT? It is a helping hand in time of bereavement, illness or heartaches of many kinds. The service is provided by a Board of Directors of 25 members and more than 400 district chairmen, co-chairmen, neighborhood chairmen, et al, all working on a voluntary basis.

WHAT DOES IT DO? It provides sick room equipment WITHOUT CHARGE for as long as may be necessary to any Sun Citian who may need it. Following is a partial list of available equipment: alternating pressure pads, (invaluable in preventing bed sores), backrests, bath benches, Hi-Lo hospital beds, canes, wheel chairs, nebulizers, breathing machines, commode chairs, crutches, excercise bikes, heat lamps, hydraulic lifts, bath tub massagers, mattress raisers, bedside tables, traction units, trapeze, vaporizers, walkers, baby beds, high chairs, rollaway beds, and many other items of sick room equipment.

The chairmen visit Sun Citians who may be alone and in time of illness and bereavement they offer their services (if they are desired). The President of Sunshine Service calls on Sun Citians who may be ill in local hospitals and nursing homes and those who have lost a loved one.

The Service provides a window card for all residents which contains vital information for use in an emergency. (These are available at the Sunshine Service Office.) The Service also helps residents get household or nursing help IN CASE OF ACCIDENT OR ILLNESS. (The remuneration paid such help is a matter between those who need help and those who work).

HOW IS IT FINANCED? Solely by contributions from individuals, organizations and clubs, memorial gifts and will bequests. While there are constant contributions, there are also constant and growing expenses as Sun City expands and more residents use the service. A larger building is being built with the generous assistance of the Del Webb Corporation.

Sunshine Service began in 1961 in a very small way. It has grown to be one of the advantages of living in Sun City. Many people who never felt they would need sick room equipment have suddenly found themselves in need of not one or two atticles, but perhaps all of the equipment needed in a sick room. Being able to borrow such equipment for as long as may be necessary relieves many Sun Citians of a great financial burden. At present Sunshine Service equipment is in some 900 homes in our community of 28,000.



Again in 1973 larger quarters were needed and the Webb Co. gave Sunshine Service a large lot at its present location with parking space for 27 cars, and agreed to build a much larger building at cost. The building was occupied in December, 1973. The moving was accomplished with the help of the Synder Transfer Co. and voluntere helpers. At this time there was \$83,726 invested in sickroom equip-ment. Themsch the acle of the old building and ment. Through the sale of the old building and with the help of the Del Webb Co. in building the new building at cost and providing the paving and parking area and the landscaping, together with money from the organization's treasury, the new Sunshine Building was paid for in full.

In 1970 when the population of Sun City was 16.000, Sunshine Service equipment was in 400 places. In 1974 with a population of 35,000 the equipment was in 1170 places. And on July 25, 1977 with a population of 42,000 the sickroom equipment was being used in 2,054 places.

It has been calculated that in 1976 through Sunshine Service, savings to borrowers totaled over Suitsmite service, savings to borrowers totaled over \$415,000.00. With the rapid growth of Sun City and the aging of the early residents, it is conceiv-able that even though the Sunshine Building has been enlarged in 1977, the Service will need even more space as the need arises.

So far as is known, there is nothing like Sunshine Service of Sun City anywhere. Those who work in it. for it, and contribute to it are proud to be a part of this thoughtful care and concern for their Jellow Sun Citians.

Dear Reverend "T",

At the March meeting of the Board of Sunshine Service former Treasurer Campbell suggested that something should be done to bring our present practice in lending sickroom equipment into conformity with our by-laws and articles of incornoration.

The prelude to Article III of these articles states "The general object of the corporation is to aid the citizens of Sun City, Arizona, in emergencies where the corporation or any one or more of its officers or members may be of assistance." Under this provision it has been assumed that the sickroom equipment may be loaned only to residents of Sun City. However, Article III, Section (g) of these articles, provides that Sunshine Service may "contract, coordinate or operate with other organizations, associations, corporations or <u>individuals</u> in carrying out and conducting the activities and endeavors for which this corporation is formed", etc.

In the past the Board has made certain exceptions in lending its equipment, including Camelot Manor, Apollo Court, Sun City Mobile Homes and the Good Shepherd Convalescent Home, all of which are not physically in Sun City. The authority for such exceptions has been considered to be the key word, "individuals", as quoted above. Recently Sun Air Estates has requested that they be added to the above exceptions, and the Board did not approve this request.

Our committee feels that the adding of communities outside of Sun City to the list of those eligible to borrow the equipment establishes a precedent which could cause difficulties in the future, having in mind that communities, such as Youngtown, El Kirge, Surprise, Feoria, Tolleson and other nearby communities, may well feel that they have an equal right to the use of the equipment.

Also, in view of the opening of Sun City West and the certainty that Sunshine Service will be called upon by residents of that community to lend equipment, our committee recommends that no by-law or article of incorporation be changed, and that the Board agree that no further exceptions be made which would allow communities outside of Sun City or Sun City West to borrow the equipment. The committee also recommends that this policy be included in the "Manual of Policy and Procedures".

The Board, at its March meeting, expressed the thought that when other communities or organizations outside of Sun City ask to borrow the equipment, the suggestion be made that they consider starting a similar service, in which case Sunshine Service would be glad to give them its advice and help. The committee is in complete agreement with this suggestion.

Although many Sun Citians have heard of Sunshine Service, there are many residents, particularly those who have come here recently, who may have either not heard of it or may have a very vague idea as to what it is and what it does. Briefly, Sunshine Service is a helping hand in time of bereavement, illness or heartaches of many kinds. Its main purpose is to provide, without charge, sickroom equipment for as long as may be necessary, to any Sun Citian who needs it. (This was not the main purpose when Sunshine Service came into being in 1961, but it has evolved over the years.) The Sunshine Building is located at 9980 Santa Fe Drive in Sun City. It is open Monday through Friday from 9:00 a.m. to 12.00 m. and from 1:00 p.m. to 4:00 p.m., and on Saturdays from 9:00 a.m. to 12:00 noon. It has a supply of sickroom equipment, among which are alternating electrically op-erated pressure bed pads (invaluable in preventing bed sores), backrests, bath benches, Hi-Lo hospital beds, wheenchairs, nebulizers, breathing machines, commode chairs, exercise bikes, hydraulic lifts, bath tub massagers, mattress raisers, bedside tables, traction units, trapeze, vaporizers, walkers, canes, crutches, and many other articles of sickroom equipment. For the convenience of Sun Citians, it also has baby beds, highchairs, playpens, potty chairs, etc. It also carries rollaway beds which Sun Citians just moving into their homes sometimes need, as well as for the use of guests.

Sumshine Service helps residents get household help or nursing help in case of accident or illness. In such cases the remuneration is a matter between those who need help and those who work.

Sumshine Service is financed solely by contributions from individuals, clubs and organizations and through will bequests, also by contributions from those who borrow the equipment. Being able to borrow such equipment for as long as may be necessary, without sharge, relieves many Sun Citians of a great financial burden and may be considered one of the many advantages of living in Sun City.

And now for a brief history of the organization. In 1961 a Sunshine Committee was appointed to help those who were unable to pay the recreation dues of \$40.00 per year (the amount set by the Board of Directors of the Sun City Commity Civic Association.) At that time there was but the one recreation center on Cakmont. These dues could be paid quarterly. Five of the nine directors donated \$40.00 each to a fund for this purpose. At the same time a Sick and Visiting Committee was named and member of the Board, Rev. E. Duane Thistlethwaite was appointed to head both committees.

With \$200 the Sunshine Committee paid dues for four homes for the first quarter. These people said they would rather pay their own dues if they could find work. So during the first quarter the Committee found work for three of them and paid only for one for the second quarter. This left \$150 in the treasury. It came to the Committee's attention that a Sun Citian had to pay \$25 to get a hospital bed for one month. The Committee had an opportunity to buy hospital beds with mattreases from Memorial Hospital in Phoenix for \$35 each. Half of the \$150 was spent for three beds



and a Sun Citian offered to buy a fourth. Thus the acquisition of sickroom equipment began. The Committee then bought some second-hand wheelchairs and walkers and some equipment was donated by residents.

The old Sunshine Committee was succeeded by a new committee, appointed by the president of the Sun City Civic Association, since the committee was operating under that association. Rev. Thistlethwaite became chairman and four women, Mrs. Carl Kays, Mrs. Joseph Asteres, Mrs. George Heath (now Mrs. Essel Dillavou) and Mrs. Warren Rogers were appointed to head the four districts in Sun City. They in turn appointed neighborhood chairmen whose duty it was to keep in touch with those in their neighborhoods, visiting those who were ill or along and those who might need help, advice or sympathy. Eventually there were over 400 of these neighborhood chairmen. With the rapid growth of Sun City, it has been impossible to continue the organization of all the newer areas through the appointment of neighborhood chairmen. However, efforts are continuing along this line. Chairman Thistlethwaite visits Sun Citians in hospitals and in their homes and several Board members have been visiting ill Sun Citians in their homes. The Chairman also visits in homes where there has been a death. Booklets expressing the sympathy of Sunshine Service are either given the family at that time or are mailed to them.

The first bed and wheelchair were loaned on April 2, 1962. All the equipment when not in use was stored in Chairman Chistlethwaite's apartment and his wife, Fern, was the telephone and office girl. That year the Sunshine Committee loaned equipment to 29 homes in Sun City. They also bought four more hospital beds.

Later the Sunshine Committee became an independent chartered orgenization and changed its name to Sunshine Service, Inc. The Del Webb Co. donated a lot and built the firstSunshine Service building at 10307 Coggins Drive. It was to cost not over \$14,000. A thermometer was erected in the shopping center to show progress and letters were sent to clubs in Sun City asking for contributions. Checks were received from clubs, organizations and individuals (the individuals were not solicited for funds). Before the building was completed, Sunshine Service had the money in the bank to pay for it. Helping Sun Citians is the sole business of Sunshine Service. Many people cannot understand why no charge is made for the equipment. But this makes it possible for those who cannot afford either to buy or rent the equipment to have it and not be embarrassed. Others can make a gift for its use. Sunshine Service has more than \$1,000 worth of sickroom equipment in a number of homes in Sun City. In 1970 when the population of Sun City was 16,000, Sunshine Service equipment was in 400 homes. In 1974, with a population of 35,000, the equipment is in 1170 homes. With the rapid growth of Sun City, it is easily conceivable that it may be necessary to enlarge the Sunshine Building in two or three years. It has been calculated that if all this equipment had been rented at current prices, it would cost \$25,869 per month! Og this same basis, Sunshine Service saved people in Sun City \$100,000 in 1973!

Nobe of Sunshine Service's officers, directors, district chairmen and co-chairmen, neighborhood chairmen and co-chairmen receive any pay for their Sunshine services. It is necessary to have two girls in the office and one maintenance and handyman in the storage area.

All gifts to Sunshine Service, Inc. are income tax deductible. While there are constant contributions, it should be kept in mind that there are continuous and growing expenses as Sun City expands and as Sun Citians get older.

So far as is known, there is nothing just like Sunshine Service of Sun City anywhere. Those who work in it and for it are proud and happy to be a part of this thoughyful care and concern for their fellow Sun Citians.

What is SUNSHINE SERVICE. INC.?

SUNSHINE SERVICE, located at 9980 Santa Fe Drive, in Sun City, loans sickroom equipment, children's equipment and rollaway beds without charge to Sun Citians who need such equipment.

SUNSHINE SERVICE is all of the people of Sun City, past, present and future, who have made this organization successful through their labors, through their utilization of our equipment and through their generosity.

SUNSHINE SERVICE gratefully acknowledges the work of hundreds of Sun Citians who have helped this organization grow. Unfortunately there are too many to make here and some whose makes have been lost with the passage of time.

It would not be possible to relate the story of this wonderful service organisation without setting forth the contributions of our founder, Rever-end E. Duame Thistlethwaite (who will be affectionately referred to as "Rev-erend F" throughout this history). Mor would it be right to not give full recognition to the major part played by the Del Webb Cospany in getting this organisation under way and in their continuing support during the subsequent years of growing pains associated with the growth of Sun City and the in-treased call for our equipment. And we must give recognition to the dedi-cated services remdered by our Administrator, Will Stevener.

"Rev. T" continued working with <u>SUNSHINE SERVICE</u> part of each working day and continued making calls on the sick. He suffered a stroke that left him blind just seven weeks before the nineteenth anniversary of this organi-sation he conceived, founded and served so long and so devotedly. "Rev. T" has been referred to in newspaper articles as "The Saint of Sun City". He now lives in Sun Valley Lodge where friends of many years and aembers of his Church regularly stop in to visit and to read to his.

The concept of serving his fellow Sun Citian in time of need without a charge is the foundation upon which <u>SUNSHINE SERVICE</u> has grown and expanded during the last twenty-two years. His presence continues to be felt at 9980 Santa Pe Drive:

As so often happens, necessity forces change. In 1975 after thirteen years of growing SUMSWINE SERVICE found itself unable to purchase insurance due primarily to insufficient record keeping procedures. The insurance firm, after studying the operation, recommended the exployment of a full time, paid takinistrator.

Administrator. Will Stavener was born on September 20, 1908, in Yorkton, Saskatchewan, Ganda. He case from a large, close family of eight brothers and three siz-ters. He completed three years at Hiagars University, Miagars Falls, New fork. In a hurry to get on with his career, he got a follow of a Chesical Oper-stor in Dafont's Hiagars Falls Plant. After ten years learning the bushees, he was prometed to Supervisor. With the advent of World War II, he was trans-ferred to a Government Plant, opersted by DuPont, where he was appointed Pro-duction Supervisor. In 1947, he returned to Niagars Palls where he was the first am into DuPont's new Nyion Division Plant. In 1953, he was transferred to Kephis, Tennesse, where he was Production Supervisor of DuPont's Hydrogen Feroxide Department. In December, 1967, Will retired from DuPont moving di-rectly to a home he already owned in Sun City. In 1965, Will stored inter four start sint in the Mutual Pund business

In 1968, Will entered into a four year stint in the Mutual Fund business and he joined the Lions Club. In 1969 and 1970, he served as President of the Most Lions Club. In 1972 and 1970, he served a Deputy District Governor of Lions Club. In 1972 and 1974, he was blocted to and served as District 21A. In 1979 and 1974, he was blocted to and served as District the vennor of mid District 2AA. In 1974 and 1975, he served as Chair-man of the Sight and Maring Pould of District Covernors. He served schairman of the Sight and Maring Pould of District Verson, a Lions organization. In 1975. Will was the Sum Clion for State of Arisons, a Lions Chairman of the Bi-Conternial Committee and the Liberty Bell in Bell Center was a remit of this Committee's work.

In 1972, Will had been elected to the Board of Directors of <u>SUMSHINE</u> STATION. He was immediately made Chairman of the Pinance Committee. In 1974-He was elected as lat. Vice Freedent serving under "Rev. T., then President. In 1974.

He immediately resigned from the Board of Directors. He took over an organization which had just written off thou-mands of dollars of squipment to inadequate records so he immediately set out to install new record is done to inadequate accords so he immediately set out to install new record is to inadequare dancing with one of the lades in Sunshne Services office and in 1979, we acquired our first electric type-writers and our first computer in 1979, we acquired our first electric type-writers and our first computer. She wrote a manual of operations which is still in use.

Meanwhile, Will was laboring to modernise and supervise a rapidly expand-ing business. For example, in 1975, our inventory of sickroom equipment totalled \$900 pieces while in 1964, our total is 12,500 pieces. In 1977, our building was expanded by an additional warehouse and will and his men designed and built all of our storage racks allowing for double decking.

With streamlined procedures and improved storage <u>SUNSHINE SERVICE</u> is handling a greatly increased volume with the same number of employes and with

less effort. Our warehouse is now a prime example of cleanliness, safety

A sense the Marion moved to Sun City in 1968, and in 1969, became involved with "Rev. T" and a growing SUNSHINE SERVICE. Marion was an inventor and a capable welter. While SUNSHINE SERVICE was still in its building on Coggine Drive, he saw a need for proper racks and shelving. He designed and fabri-cated steel racks and shelves in his own garage and transported them to the Sunshine Service Warehouse. After he had finished this work, he took over the responsibility for the repair and reconditioning of our lean equipment. He performed this work almost single handedly until we moved into our pres-tor our new warehouse. Wr. Marion proved a true friend to <u>SUNSHINE SERVICE</u> and his talent, time and effort spent on our behalf certainly earned him a special place in this history.

In covering the twenty-two years of <u>SUNSHINE SERVICE'S</u> existence, we are proud to recognize the giant contributions made by "Rev. T" and Will Stevener to this organization that helps make Sun City a most desirable place

Frior to April 1, 1962, there was a Sunshine Committee and "Rev. T" was its Chairman. They divided what was then the area of Sun City into four seg-ments, each with a Captain and each with a driver. The Committee existed to help Sun Citians in need, but did not loan equipment. They would drive a meighbor who needed help to the doctor, to the hospital or to the grocery store. A card placed in a window would soon bring a neighbor to see what help they could render. The Sunshine Committee predated <u>SUNSHIME SERVICE</u> and it too was a wonderful organization formed for the purpose of neighbors help-ing one another.

Ing one another. As previoually stated, <u>SUNSHINE SERVICE</u> started its business life in the Carport of Rev. T's' heas at 10643 Oakmont Drive. As the volume of equip-ment loans graw, so did the inventory grow. This growth reflects the utili-sation of Sun titlans of this service as well as their generoaity towards <u>SUNSHIE SERVICE</u>. It soon became essential that a larger and proper business <u>SUNSHIE SERVICE</u>. It who be development Company came to our aid donating a site at 10300. When Sun Citlans heard about this, enough soney was donated to pay for the building before it was completed. <u>SUNSHIE SERVICE</u> occupied its new location in July, 1965. But Sun City key growing in population and the volumes of our loans kept growing. By 1966, we were in a space runch and as again the bel Webb Development Company came to our aid and agreed to build as adding on the service our aid and agreed to build and agrees to building for 39,000.00. of Sun City came to our aid and contributed the needed funds. Many of you will remember the rapid expansion of Sun City in the early seventies. So, in 1973, we again found ourselves with a severe space problem and with no room to grow. Again the Del Webb Development Company came to our rescue and donated to <u>SUNSINE SERVICE</u> a large lot at 9980 Santa Fe Drive, our present location. Our new building was completed and occupied in December, 1973. Through Del Webb Development Company building at cost, through the sale of the old building, through the continued generosity of Sun Citians, and with funds on hand, the new and larger facilities were paid for in full. The growth continued and so in late 1976, we again found ourselves with another space problem. The new familiar story is again repeated and Del Webb built an additional warehouse at the rear of our present building. This additional space was dedicated in October, 1977, and paid for in full. SUNSHIME SERVICE, INC. now has 14.563 square feet of warehouse space. Another 1100 square feet of storage space is available through double decking. We currently stock 89 different categories of sickroom equipment totaling 12,500 separate pieces. In addition, we have 1176 separate items of rollaway

befs,) sizes of crids, strollers, highthairs and nursely chairs. With our computerised accounting, we now conduct an annual inventory each April 1st. All items belonging to <u>SURKINE SERVICE</u>, whether out on loan or in our warchouse, are identified and counted. To neet the demand for the loan of equipment, we regularly mak Sun Climan to return equipment no longer in use or when they leave Sun Clty for extended visits. Such returned equip-ment is thoroughly cleaned and reconditioned by our warchouse staff and placed back into inventory. This procedure helps us meet our goal of not having to disappoint any Sun Citian who needs the loan of our equipment.

Will Stevener watches our inventory closely culling out irreparable items and mesking out modernised or improved equipment. The smaller, compact cars have had an effect on our inventory. For example, walkers that will not fold are now less desirable as they will not fit into the small cars. Our inven-tory is not static; it is constantly under review and expanded and improved to meet the needs of Sun Citians.

The pattern of utilization of our equipment by Sun City homes is illus-trative of our growth and expansion. In 1970, with a population of 16,000, we had equipment on loan in 400 Sun City homes. In 1974, with a population of 35,000, we had equipment in 1170 homes. In 1981, with a population of 48,000, our equipment was in 2000 homes. And last year, 1983, our equipment was in 3200 Sun City homes.

How helpful to Sun Citians has our service been? A look at the last three years speaks clearly to this question. Based on conservative estimates of money savings provided to Sun Citians for the loan of sickroom equipment as compared to rental charges we find:

The above figures do not include the loans of rollaways, cribs, high-chairs, etc. If a rental charge on such items were considered, our savings to Sun Citians would be even greater.


