



## Brewers Find Winter Home In Sun City

# **Ownership** to pursue **Brewers**

### New stadium bosses hope to block move

SUN CITY - The new owners of Sun City Stadium plan to renew efforts to keep the Milwaukee Brewers from moving their springtraining camp to Chandler in 1985.

Bade Boyes Partnership, which operates B&B Construction and Development of Glendale, purchased the stadium Friday from Del E. Webb Development Co.


Gerald Bade, the firm's treasurer, confirmed his company bought the stadium but declined to disclose the purchase price. The stadium, with a seating capacity of 4,000, is at Grand and 111th avenues.

"I've talked to the Brewers a couple of times and expressed our desire to have them stay there.' Bade said, but the Brewers have signed a letter of agreement to move to Chandler in 1985.

Harry Dalton, the Brewers' general manager, said the American League team's board of directors probably will decide at an October meeting whether the Chandler move should be approved.

The team's directors, though, rarely reject the general manager's recommendations, Dalton said.

However, he said, the move will not be certain until the board approves it and Chandler lives up

to the agreement by building a property as a stadium for five years, stadium.

The Chandler agreement calls for the Brewers to sign a 5- or 10-year lease at a yearly rent of \$120,000 to use the yet-to-be-built stadium.

The Brewers' move to Chandler is being organized by Bob Dossey, president of the Chandler Chamber of Commerce.

Meanwhile, Bade said, he will try again to convince the Brewers to stay in Sun City beyond April, when their lease expires. A plan to lure the Brewers back to Sun City Stadium has not been developed vet, he said.

If the Brewers move to Chandler, another major-league team will be sought to lease the stadium, Bade said.

Webb President Fred Kuentz said terms of the transaction require new owners to maintain the until Jan. 1. 1988.

Joe Davisson, president of the Sun City Saints Boosters Club, said fans have been worried that the Saints, an amateur women's softball team, would have no place to play if Webb sold the stadium for commercial development.

Therefore, "that's definitely good news," Davisson said of the conditions imposed on new owners through the stadium's sales agreement.

"That means the Saints should be able to play there for five years," Davisson said.

Webb's sales agreement specifies that the stadium will be made available to the Saints, Kuentz said, and the five-year moritorium on using the property for a purpose other than a stadium also makes it possible for the Brewers to stay.

Kuentz described the stadium as

farm teams are signed to train through 1989.

"a loser for us" of at least \$40,000 to \$50,000 each year.

He said the stadium was also Webb's last asset in Sun City, and the company wants to devote all of its money to Sun City West's development.

Phil Brant, Webb's manager of commercial sales and leasing, said the stadium was sold to the Glendale firm after the Brewers refused to buy it.

The conditions placed on the sale to Bade gives the Brewers a chance to remain as tenants if the contract with Chandler falls through, he said.

The provision that calls for the property to remain a stadium for five years was stipulated because "we don't want to be irresponsible by abandoning a community we've developed since 1959," Brant said. - Jim Walsh
