# **Rotarian reaches out to Peruvian exchange student**

Jim Green of Sun City is proof that for Rotarians, the world has no boundaries.

Green, assistant governor for the Northwest Valley Rotary Club and member of the Sun City Rotary Club, recently returned from a journey through several cities of Brazil. And for three months, a 17-year-old exchange student from Arequipa, Peru, will live with him.

Green's trip to Brazil was anything but a leisurely vacation. The monthlong trek was part of Group Study Exchange, a 41-year-old program sponsored by Rotary International that gives Rotarians and non-Rotarians a glimpse into vocations and careers around the globe.

"Our mission is to promote goodwill and to learn about vocations in other parts of the world," said Green, who led a group of four non-Rotarians during the trip. "I lived there, I wasn't a tourist. It was one of the most valuable experiences of my life."

San Paulo, Araguari, Rio Verde and Araxa were some of the group's destinations. At each stop, the travelers stayed in the homes of Rotary member families. Sun City Rotarians will be host to teams from Brazil and south east India in April and May. "We're more than guests, we're Rotarian friends. Wherever we go, we always have something in common," Green said. "The best part of the trip was getting to meet the people and to see what they did."


As a president of the Sun City Community Fund, Green is familiar with fund-raising. While visiting a hospital, he was able to help the staff generate fund-raising ideas.

"Fund-raising is not a standard thing there. There are no incentives for people to give," he said. "And very little of the money allocated to the people actually gets to those people."

Cesar Rivera, 17, recently embarked on his own adventure with the help of Rotary International. Rivera, whose mother is a Rotarian, is a participant in Rotary International's Student Exchange Program.

"Young people are the world leaders of tomorrow," Green said. "If we can give them an international understanding now, we help make them better world leaders."

Rivera arrived in July and will stay in different homes throughout the Northwest Valley for a year. Seventeen high school students from around the Northwest Valley also are traveling the world as part of the exchange program. DAILY NEWS-SUN TUESDAY, OCT. 18, 2005 A3

Until November when he moves to another Rotarian's home in Surprise, Rivera will stay in Green's Sun City home. He attends Willow Canyon High School in Surprise.

"Î like it here. I like the people," Rivera said, adding that he's already made friends like Oliver, a Slovakian Rotary exchange student staying in Avondale. The two play tennis at Lakeview Recreation Center as Green's guests.

"This is a good experience, to know about American culture and the people here," he

said.

Rivera said he plans to attend college in Peru next year, majoring in business administration. Someday, he said, he'd like to start his own business. For now, he's focused on honing his English-speaking skills. Rivera said he enjoys his temporary Sun City lifestyle.

"It's a very quiet place," he said.

# Rotary boosts guardianship project coffers

The Guardianship Review Project received a boost from the Sun City Lakeview Rotary Foundation.

The club donated nearly \$2,000 to the seven-year-old project that was launched by Sylvia Cartsonis, executive director of the Northwest Valley Regional Community Council.

The Guardianship Review Project is the result of a 1988 conference that determined the court was not meeting its legal responsibility to monitor wards because of a lack of court personnel and resources.

Now, more than 35 volunteers, known as court visitors, act as the eyes and ears of the Maricopa County Superior Court by visiting wards of the court or people under guardianship to make sure they are receiving the proper care.

What began as a pilot project in the Sun Cities has unfurled into a program that serves people in Glendale, Scottsdale, Tempe and, most recently, Phoenix. More than 1,500 cases have been reviewed and about 350 are still active, said Roxanne Hernandez, the program coordinator.

The program is particularly vital to the Northwest Valley.

"Many people here don't have much family," Cartsonis said.

Before volunteers are accepted into the program, they undergo background checks through the Maricopa County Sheriff's Office and receive four days of training over the course of a month.

About eight volunteers from the Sun Cities are involved in the project.

Betty Lattin of Sun City has been volunteering for four years.

"It's quite interesting, but it's fairly depressing. But you just have to accept that and not let it bother you," Lattin said.

When making visits, volunteers check to see if the ward is receiving the proper food, clothing and shelter.

Grants were made to:



# Local Rotary Club donation benefits Dysart science class

Two Utah chemists may not have created nuclear fusion in a bottle, but two retired Sun Cities chemists have helped bring about fusion of a different sort.

The "energy" has to do with a classroom; the interaction of can-do adults challenging students to explore the world of chemistry.

To compete in this high-tech society,

students entering Arizona universities, community colleges, business or industry need backup experience with state-of-the-art equipment, says Dysart High School chemistry teacher Jayne Theis.

After checking out the meager and outdated supplies being used in Dysart's chemistry program, a Sun City Rotary Club put \$2,000 worth of new laboratory equipment to work.

"Sun Citians believe in education," says Roy Heath, former chemistry professor, now "They didn't have proper equipment to bring out for experiments ... They didn't even have an aneroid barometer,"

president of Del Sol Rotary Club.

Proof is in the front-line assistance for students who have been working without benefit of modern developments in color photometry, chromatography, molecular structure and accuracy in measurements.


Dysart chemistry students share a classroom that doubles as a laboratory. There are eight lab benches, with equipment for only four.

"They didn't have proper equipment to bring out for experiments ... They didn't even have an aneroid barometer," Dr. Heath says.

Sun City West resident Vincent Marchese is senior volunteer in the Dysart High School chemistry department, which he "discovered" three years ago, shortly after he moved to the community. He was out driving and found the high school.

"I walked in, I said 'I'm here ... can you use me?'" They could, and they are.

Volunteer Marchese is a graduate chemical engineer and now has charge of the laboratory,

sets up gear and makes solutions.

"I lecture, occasionally," says Mr. Marchese.

Mrs. Theis describes her volunteer assistant as "an aggressive catalyst who has caused this reaction."

He goes nearly every day to the high school to work with three first-year chemistry classes. There are between 12 and 18 students per class.

There are some serious students who are going on to chemistry, he says. Some want to take advantage of the opportunity. Next year there will be five classes.

Rotary del Sol's interest has been piqued. Club members are considering additional assistance for Dysart chemistry and are looking at the high school physics program as well.

Mr. Marchese says the chemistry department is still low on equipment. "There's little instrumental analysis. We need equipment. We're trying hard to get some money — we'd love to get a new wing."

Chemistry shares a classroom with biology, he says. "This makes it hectic. You only have 55 minutes and setups take time."

The volunteer assistant has praise for Ms.Theis and her work with the students. A few of her most serious students may study college-level chemistry next year.

The "aggressive catalyst," Mr.

Marchese set the ball rolling with a talk he made recently to 40 local members of Alpha Chi Sigma Chemistry Club. At that time he described the limitations in the chemistry equipment at the neighboring high school.

As a member of the chemistry fraternity, Dr. Heath heard the speech and relayed the senior volunteer's story to his fellow Rotarians.

"This resulted in expansion of Rotary Del Sol's support for Dysart High School," Dr. Heath says.

The club was able to purchase an analytical balance, a color photometer, three magnetic stirring tools, a centrifuge, an aneroid barometer, six magnetic molecule sets and a chromatography kit.

# Rotarians plan awards, local grants carefully

Rotary is a service organization, and the members of the Sun City Rotary Club take their commission seriously.

They don't subscribe to massive yard sales, heroic collections of rags and bottles, ticket sales for concerts, pageants, circuses and games or round trips to and from the hinterlands.

Instead, they give money. Money that goes to the Sun City-Youngtown Rotary Foundation, which is the charitable arm of this, the first Rotary club of Sun City.

In 1986, the foundation made awards amounted to \$9,146. In 1990, the total had grown to \$12,084.

The five-year total amounts to \$51,137.

Funds come from donations, cash gifts, bequests, gifts of property and securities, as well as memorials and in naming the foundation as beneficiary of insurance policies.

Each member of the Sun City Rotary organization is automatically a member of the club and the foundation.

Organized in 1969, the foundation's affairs are managed by a board of directors assigned to promote and encourage giving to the foundaover See AWARDS, page 9

They also see that the foundation funds are invested wisely and that the he organization's tax-exempt status is protected.

"Our grants are of significant benefit to local organizations and individuals," says Bob Graham, foundation president.

"Significant" is a noticeable reflection in the pride the Rotarians take in their service programs.

Particularly, they're proud of their grants for education, which, they say, help counter those erroneous reports circulating throughout the Valley that Sun Citians don't like kids.

Brad Smith, chairman of the club's Grants Committee, says "We think Maricopa County is where our charities should go." In fact, the circle is drawn even tighter, as a large percentage of the Rotarians' donations stay in close proximity to Sun City.

Mr. Smith says the committee researches requests as they come in.

"Everyone in the club submits candidates for grants, and the committee screens them," he says. "As much as we can, it's the intent of the committee to keep them within 10 miles of Sun City. A substantial percentage goes to schools and 63 percent goes to education."

The grants pinpoint, primarily, school functions that don't have funds; provide funds for summer school in some instances for the youth who can't afford it, but need the extra attention, Mr. Smith explains.

"All donations are thoroughly researched to determine how the money will be used, and what the needs are."

One donation goes to a literacy program, teaching English as a second language; another is a scholarship for a Sun City resident who is trying to go through nursing school. Junior Achievement benefits with a business class in the Peoria School District.

Centro Adelante Campesino, a group based in Surprise that helps farm workers with breakfast and a bag lunch, is a fund beneficiary.

"It's a rule of the fund: any money has to stay in Arizona," says Joe Johnston, foundation treasurer. "And we're quite concerned that we are not giving money away where it is not deserved."

Mr. Smith adds that other places may also be deserving, but may have other fund-rais-

ing benefits or capabilities of their own. The committee also looks at the degree of need.

Pointing to the Rotary Club Foundation awards made over a five-year period, Mr. Johnston says the basic purpose of the foundation is growth, so there will be more money to give away in grants.

"We have a pretty good track record," he says.

As announced April 12, at the Sun City-Youngtown Rotary Foundation dinner, grants were given over the past five years in education (63 percent of the total); local charities, 29 percent and library, arts and music, 8 percent. Some 18 percent of the recipients during the period were Sun Citians.

The 1990 grants were awarded to the following:

Dysart Community Center, Laubach Literary; Dysart Community Center, building expansion; Solecito Services, Sun Sounds, Sun City Symphony (Butterfield); Peoria High School summer school, Peoria Schools dropout prevention; Arizona State University scholarship (Jeff Davey, Dysart High School graduate); and Sun Valley Lodge assistance fund.

Also included were Centro Adelante Campesino, Hospice of Sun City, Glendale Community College of Nursing, Habitat for Humanity, Junior Achievement, Peoria program); Salvation Army backto-school; Westside Food Bank, Sun Health Cancer Research Fund, Sun Cities Area Community Council (for Olive Branch Senior Center).
